Performance represents annualized percentage change in net assets of separate accounts, the performance of the underlying portfolios and the charges that would have been made during the periods shown. - Allocation Risk
- The portfolio's percentage allocation to equity securities, debt securities and money market instruments could cause underperformance when compared to relevant benchmarks and other portfolios with similar investment objectives. - 2. Asset Class Risk

31. Mortgage & Asset-Backed Securities Risk	Mortgage-backed and asset-backed securities are subject to changes in the payment patterns of borrowers of the underlying debt. When interest rates fall, borrowers are more likely to refinance or prepay their debt before its stated maturity (Prepayment Risk).
