**Product Performance Description** 

Variable annuities provide access to a wide range of professionally managed investment choices within the contract. These choices range from equity investment options to bond and money market investment options, enabling you to create a portfolio designed to meet your investment objectives. The value of an investment in a variable annuity will vary depending on the performance of the investment choices you select. Investment choices are subject to market fluctuation, investment risk and possible loss of principal.

Performance represents annualized percentage change in net assets of separate accounts, the performance of the underlying portfolios and the charges that would have been made during the periods shown. Allocation Risk	The portfolio's percentage allocation to equity securities, debt securities and money market instruments could cause underperformance when compared to relevant benchmarks and other portfolios with similar investment objectives. 31. Mortgage & Asset-Backed Securities Risk	Mortgage-backed and asset-backed securities are subject to changes in the payment patterns of borrowers of the underlying debt. When interest rates fall, borrowers are more likely to refinance or prepay their debt before its stated maturity (Prepayment Risk). This may result in the portfolio having to reinvest the proceeds in lower yielding securities, effectively reducing the portfolio's income. Conversely, if interest rates rise and borrowers repay their debt before its their debt slower than expected, the time in which the mortgage backed and other asset-backed securities are paid off could be extended (Extension Risk).
32. Non-Diversification Risk	Poor performance by a single large holding could adversely impact the portfolio's investment results more than if the portfolio were invested in a larger number of issuers.

Operational & Tech- nology Risk	Cyber-attacks, disruptions, or failures that affect the service providers or counterparties, issuers of securities held by the portfolio, or other market participants (including exchanges) may adversely affect the portfolio, includ- ing losses for or impaired operations.
