Fort Washington's Short Duration Fixed Income strategy seeks to actively manage portfolios within a disciplined sector rotation and target duration framework, focusing on long-term results, utilizing a mix of fixed income securities such as Investment Grade Corporates, Securitized, and US Government with a maturity up to five years. Fort Washington constructs portfolios that are diversified by sector, holdings, and quality, which we believe will produce favorable risk-adjusted returns. The Short Duration Fixed Income Composite includes all fixed income accounts above \$5 million managed consistent with the Short Duration sector and maturity objectives. The Short Duration Fixed Income fee is 0.25% for the first \$25 million and 0.20% on additional amounts over \$25 million for separate accounts. The benchmark for this composite is the Bloomberg 1-3 Year US Gov/Credit Index. This index includes all medium and larger issues of U.S. government, investment-grade corporate, and investment-grade international dollar-denominated bonds that have maturities of between 1 and 3 years and are publicly issued. Cash is maintained, within each separately managed account segment, in accordance with our asset allocation ratio. The U.S. dollar is the base currency. Returns are presented gross and net of management fees and include the reinvestment of all income.
